1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Bhawabhuti Mahavidyalaya, governed by Bhawabhuti Shikshan Sanstha with its clear statement of vision and mission, was established in the year 1969 in Amgaon, a tahsil place in Gondia district (M.S.). The place Amgaon is on the railway route, just at a distance of 25 KM from Gondia, a well known railway station on South-East region of railway. The college is also situated in beautiful surroundings of Hillocks. The region is at the outskirts of two different states – Madhaya Pradesh and Chhattisgarh. The population of Amgaon village (Tahsil Place) is approximately thirty thousands. College provides higher education in the rural and educationally backward area. It is a grant-in-aid institution and provides the co-education facility to the students. At present college is established in separate premises having an area more than 10 acres and total built up area of the college is 63,330 sq. feet and at present 974 students are enrolled in various streams. The entire necessary infrastructure, such as class rooms, laboratories, library, sports, drinking water facility, girls' common room, lavatories, continuous tap water and solar power generation are provided. College is permanently affiliated to Rashtrasant Tukadoji Maharaj Nagpur University Nagpur. The college has a large playground available for outdoor sports and athletic events. Along with undergraduate courses (UG) in Arts, Commerce and Science, post graduation courses (PG) in Arts (Marathi and Economic) and science (Botany and Zoology) are run by the college. The college also runs the Ph. D. Programme in Botany and Zoology. The college library holds more than 30,000 books. The complete library is updated with cloud based software. Various committees are in existence for smooth working of curricular, co-curricular and extracurricular activities of the college. Most of the students either avail GOI scholarship or EBC facility and a few students are fee paying. It clearly indicates that students are either from economically weaker section or having lower learning competence. The steering committee prepared the Self Study Report of the institution. All the members of management, CDC, faculty and supporting staff actively contributed in the preparation of SSR.

- Percentage of students' placement is very low, since it is not a professional institution.
- Percentage of students qualifying NET/ SLET/ State Government/Civil Services examination is very low.
- Economic contribution from the alumni is very low.

- Professional development programmes for staff members could not be organized.
- Participation of non-teaching staff in professional development programme needs to be focused.
- Green Audit and Energy Audit not done on regular basis.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The college is on grant-in-aid basis and provides co-education facility and is affiliated to Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur. The college implements the curriculum designed by the parent university, that is, Rashtrasant Tukadoji Maharaj Nagpur University. Following features are notable in the institution regarding implementation and accomplishment of the curriculum.

- The college runs BA, B Com and B Sc Programmes at UG level. The students have the choice of studying various courses/subjects through these programmes. At PG level the college runs MA programme in Marathi and Economics subjects and M Sc in Zoology and Botany subjects.
- The college runs semester pattern and CBCS scheme programmes.
- In accordance with the University Academic Calendar, the college prepares well in advance the College Academic Calendar for the upcoming academic session.

- Preparation of Time Table at the beginning of the session for theory and practical classes.
- For the effective teaching delivery of the curriculum various teaching methods are applied. The conventional as well as advanced teaching-learning aids are used such as chalk and blackboard, ICT enabled tools, etc.
- For the effective implementation of curriculum organization of industrial visits, field visits, seminars, group discussions, workshops, guest lectures, study tours, etc. by the departments.
- Organization of bridge course, remedial coaching, extra classes by the faculties.
- Well equipped laboratories for the practical classes.
- Well equipped central library with a separate reading hall with sitting capacity of 60 students, a stacking room, a reference section and e-library. The e-library provides the facility of open access to INFLIBNET, various books, national/international journals and other resources.
- Organization of various co-curricular, extracurricular, cultural and sports activities as per the college academic calendar throughout the session.
- Organization of add-on courses and career-oriented programmes that enhance the employability of the students.
- Integrating crosscutting issues like gender sensitization, environmental sustainability, human values, and ethics through the co-curricular, extracurricular and extension activities.

Structured feedback from the stakeholders – students, teachers, alumni, employers, - on teaching learning experiences, library facilities, sport facilities, physical and academic facilities and administration.

Teaching-learning and Evaluation

As the institution is affiliated to Rashtrasant Tukadoji Maharaju Nagpur University, it follows the rules and regulations laid down by the parent university. The institution follows the following procedures and methods for the implementation of admission, teaching-learning and evaluation process.

- The institution strictly follows the admission process as per the instruction received from the parent university.
- There is an Admission Committee for the smooth functioning of the admission process.
- Detail information regarding the courses and admission is published in the college prospectus and displayed on college website.
- More than 70% of the students admitted in the institution are girl students.
- Reservation policy for admission is strictly followed as per the norms of affiliating university and Government of Maharashtra.
- Full Time, Clock Hour Basis and Temporary Teachers appointed by the institution endeavour hard for the completion of the prescribed syllabus.
- For Teaching-Learning process faculties adopt student-centric methods such as experiential learning, participative learning and problem solving methodologies.
- Use of digital tools like latest configuration computers, LCD Projectors, etc.
- Sometimes the teachers use lecture method, interactive methods, classroom assignments, field work method, computer-assisted method and experiment method for enhancing learning experiences.
- Most of the faculties from science stream adopt ICT based methods for

teaching –learning activity.

- During COVID-19 Pandemic, the institution adopted online mode for teaching-learning process via.

WhatsApp group of students, Google Meet, Zoom, etc.

- 60% faculties in the institution have highest academic qualification as PhD.
- Continuous Internal Evaluation (CIE) is done through unit tests, assignment submission, seminar presentation, group discussion, project work, etc.
- The institution has constituted Grievance Redressal Committee for resolving examination related issues.
- The COs and POs are well defined by respective subject faculties and are displayed on the institution website.
- The attainment of POs and COs are marked through laboratory practical, seminar presentation, unit tests, home assignments and university examination results.
- Student Satisfaction Survey (SSS) on teaching –learning experiences is conducted through the questioner consisting of recommended questions from NAAC.

Research, Innovations and Extension

The Trustees and the Head of the institution always encourage the faculties for the research activities. The efforts taken by the institution and the faculties of the institution regarding research and extension activities are as follows

- The institution has an inspiring ecosystem for innovations and transfer of knowledge. It has well built infrastructure and updated laboratories for conducting practical classes.
- The college organizes seminars, workshops, book exhibition, MCQ quiz, study tour, guest lectures, and so on.
- The institution is recognized as “Centre for Higher Learning and Research” by the affiliating University in Botany and Zoology subjects. 3 students are their research work at this research centre in Botany subjects.
- Well equipped e-library providing the facility of e-resources - books, journals, periodicals, NLIST consortia, etc.
- Competitive examination guidance cell to prepare students for state and national level competitive examinations.
- Organization of seminars, poster competition, and quiz competitions on science related topics by Science Forum.
- Organization of various awareness programmes about biodiversity and wildlife conservation by Nature Club.
- 60% teaching staff members have the highest qualification as Ph. D.
- 2 faculty members in the institution are recognized supervisors.
- Total 132 research papers have been published in various notable peer-reviewed or UGC Care list journals.
- Total 6 books have been published by the faculty members as single or co-authors.
- Total 10 chapters have been published in edited volumes/books.
- Total 23 research papers have been published in conference/workshop/seminar proceedings.
- The institution has organized various extension and social awareness activities through NSS Units of the college. These include – Awareness rallies on AIDS, Population Control, Literacy, Cleanliness, plastic free village campaign. Organization of One Week NSS Special Camp in the nearby village where various cultural and social awareness activities are conducted.
- During COVID 19 Pandemic the Women Hostel of the intuition was used by the Government as a COVID Care Centre where NSS students worked as volunteers.

One of the NSS volunteers was awarded with “COVID-19 Warrior” by the affiliating university for his services at this centre.

Student Support and Progression

The faculty members have been given liberty to apply various student friendly pedagogical approaches for teaching-learning activity for the fruitful implementation of the prescribed curriculum. The institution has planned to start the process of registration of students for ABC from the session 2023-24 (from the month of July 2023).
3. Skill development:	Various curricular and extracurricular committees have been formed in the institution to provide a platform to the students to mould their personality in a right way. Through these committees various programmes focusing on human values, ethics and skill development are organized in the institution. The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Imparting quality education has been the commitment of Bhawabhuti Mahavidyalaya, Amgaon since inception in various fields of humanities, commerce and science so as to help the overall development of the students. The institute is affiliated with the Rashtrasant Tukadoji Maharaj. Nagpur University, Nagpur. As per the guidelines of parent university, admission process is done. The curriculum is designed and revised by the Rashtrasant Tukadoji Maharaj Nagpur University; Nagpur. In accordance with university academic calendar, college academic calendar is prepared by college calendar committee for every session. For the successful and timely implementation of the curriculum, the time table committee of the college prepares a timetable after the discussion with all the faculty members at the beginning of the session. Each department conducts departmental meetings for the distribution of workload. Every year, new student orientation program for first year students is organized so as get all the information about institution. For the effective delivery of curriculum, various teaching methods are applied based on the requirement of the subject, both the conventional and the advanced teaching-learning aids are used in delivering the lesson, such as Chalk and Black board method, ICT-enabled teaching-learning methods . Apart from this, educational tours, workshop, seminars, guest lectures, computer awareness program are organized for the betterment of students. Assignment, unit test, group discussion, projects are conducted as a part of internal assessment. Remedial classes are conducted for slow learners to reach the minimum qualifying level. In case of loss of regular working days, extra classes are conducted to ensure the number of academic days as stipulated by the syllabi. In order to update knowledge, faculty members attend orientation program, refresher course, short term courses, workshops, seminars, conferences etc. Student guidance center, career katta help students prepare for competitive examinations. 2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

Our institution enhances the learning experience of students by adopting student-centric methods like experiential learning, participative learning and problem solving methodologies both inside and outside the classroom. Student-centric learning helps in the holistic development of the student resulting in improved learning and development of skills. College provides necessary digital tools like latest configuration computers, LCD Projectors, Interactive boards etc., For enhancing learning experiences the faculty members adopt many ways, for example lecture method, interactive methods such as interrogative, inquiry based, guided inquiry, classroom assignments, computer-assisted method, experiment method, etc. Some teachers use power point presentations and computer-based materials. Some Student centric methods are given below:

Experiential learning:

- Experimental/Laboratory method is used in science subjects to acquaint the students with the facts through direct experience individually.
- Theory classes supplemented with practical facilitate students to understand theoretical concepts in better way.
- Department-specific activities like one day field trips, study tours which are part of curriculum of botany and zoology.
- Illustrations, demonstrations of models, slides, specimens and charts which take students beyond classrooms to foster their critical thinking and enhance their interpretation capabilities.

Participative Learning:

- UG and PG students use power point presentations in online and offline mode along with traditional chalk board method for their seminars.
- Participation in seminars, guest lectures, workshops, conferences provide varied learning experiences to the students.
- Extension activities inculcate the sense of commitment to serve the society.
- As a part of their soft skills enhancement, department of English imparted communications skills in English.
- Student's participation in science exhibitions, poster competitions, intercollegiate competitions, cultural events, local/district/state/national level sports and games evoke entrepreneurial skills, scientific temper, creativity collaborative ability and responsibility among the student.

Problem-solving Methodologies:

- Individual and group assignments are given at both Undergraduate and Postgraduate levels.
- On-field activities like Industrial visits, study tours and field trips give a real life experience to look at things and solve the problems in a self-disciplined manner.
- Mentor Mentee activity run by our college for the useful methods to solve student's personal problems related to difficulties in Syllabus and others especially during Lockdown using virtual meetings.
- Discussion forums like talks, seminars arranged as part of group activities provide a platform for students to explore various avenues to solve their academic as well as general problems.

MECHANISM OF INTERNAL ASSESSMENT:

Our Institution has an exclusive policy of internal evaluation and is committed to provide the students with Various internal assessments that track, measure, assure the quality. Apart from the University examinations. College adopts several types of assessment methods to ensure consistency of quality Quotient.

1. In order to ensure transparency in internal assessment, the system of internal assessment is Communicated with the students well in time.
2. At the entry level, admissions are given purely on merit basis and the lists of merit students are displayed on notice board.

3. Continuous evaluation is made through Group Discussion, Unit Tests, Assignments Submission and Seminars Presentation.
4. In our college, Unit Tests are taken by the respective subject teachers after the completion on prescribed topics.
5. Personal guidance is given to the poor performing the students after their assessment.
6. Students appearing for Second /third year are asked to deliver the seminars of the concerned subject. Topics are given by their teachers to the students to prepare for power point presentation.
7. Every department keeps the unit test data in the software for the transparency in the evaluation process.
8. For transparent and robust for internal assessment, the following mechanisms are conducted

The method of internal assessment helps the teachers to evaluate the students more appropriately. Due to internal assessment, the interest of the student towards learning and attending the classes has been also increased. The seminar presentation improves the communication skills of the students which is very essential to face the interviews. The winter-2021 university examination is conducted by college in online mode as per university Guidelines. Students got time table before 20 days of examination through WhatsApps groups. During the session 2021-22, due to covid-19 pandemic, the internal assessment was done through online mode via. Google forms.

MECHANISM TO DEAL EXAMINATION RELATED GRIEVANCES

A transparent, time-bound and efficient method is being followed in Our institution in terms of dealing with internal examination related grievances. Various internal examinations are being performed throughout the semester.

Internal Assessments: Immediately, after the unit test, the solution of the test along with question wise marking scheme is displayed on notice board within an hour after the test to maintain transparency and uniformity in the assessment of the internal tests. The faculty evaluates the papers within a week of conduction of test. The evaluated answer sheets are shown to students in class and faculty undertakes individual grievances with a student on the paper if required by the student. At the end of the semester the average marks of both the unit-tests is calculated and verified with the students. Any discrepancies resolved by the faculty immediately.

Assignments: Faculty evaluates assignments based on the assigned topic which is also shared with the students. The assigned topic consists of criteria- timely submission, clarity, neatness, etc. The evaluated assignments are given back to students thus maintaining the transparency of the marks assigned and to resolve grievances if any.

Response:

The institution runs the UG programmes such as –B. A., B. Com., B. Sc., and PG programmes such as M. A. in the subjects Marathi and Economics and M. Sc. in the subjects Botony and Zoology. To provide physical and academic facilities to run these programmes the institution has two main buildings. The first building, that is, Arts and Science Wing is chiefly used for running the classes of arts and science streams.

The facilities available on the ground floor of this building are as under- Principal Office, Administrative Office, Computer Science Laboratory, University Examination Room, etc. On the first floor of this building the provided facilities are as – Conference Hall, Mathematics Department, etc.

The second building, that is, Commerce Wing is chiefly used for running the classes of commerce stream. The facilities available on the ground floor of this building are as under- Guest Room, Staff Rooms of Arts and Commerce Departments, Instrumentation Lab for Research in Higher Education, Central Library, etc. The facilities available on the first floor of this building are as – Home-Economics Laboratory, class rooms, etc

Separate buildings are available on the college campus for the facilities such as – Women Hostel and Indoor Sports Hall.

The institution provides ICT facilities in the laboratories, e-library, seminar room, and conference hall. These rooms/laboratories provide the facilities of computers, printers, scanners, internet, overhead projectors, etc.

The institution provides adequate facilities for extracurricular activities such as sports, games, gymnasium, yoga and cultural activities. For indoor sports and games the college has an indoor sports hall having the area of 1336.68 Sq. Meter. It is used for the practice of the games such as – badminton, chess, table tennis, wrestling, taekwondo, etc. A well equipped gymnasium is available in the college. This gymnasium is used by the regular and ex-students of the college as well as by the local aspirants.

A huge ground is available inside the college boundaries itself. This ground is useful for the regular and

ex-students of the college for the practice of various outdoor games and sports. Moreover it is also utilized by the regular and ex-students of the college for the purpose of physical training programmes for the entry in defense and police departments.

The institution has an adequate conference hall equipped with the ICT facilities. It is utilized throughout the year by the college and local government authorities such as Police Department, Tahsil Office, Panchayat Samiti, local Health Centers and local Civil Court for the organization of various cultural and informative activities/programmes. 4.2 Library as a Learning Resource

4.2.1

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

The college has a well-furnished Library. The institution used ILMS software - LIBMAN in the central library from the academic year 2011-12 to the academic year 2020-21. The ILMS software - LIBMAN was updated in the academic year 2021-22 and the whole central library was made fully cloud based. The institutional library has a big reading hall, a well-managed stacking room, a reference section, and an e-library. It is provided with an OPAC counter to search the books. Its functioning is managed with the software LIBMAN. Likewise the students can search the desired book in the library through their mobile by downloading the app M – OPAC as the whole library is cloud based. A register is also kept in the reading hall to mark the entry of the students in the reading hall. A Book-Issue Register is maintained at the book issue counter. Likewise the record of the books issued by the teachers is maintained properly. To issue books to the students library provides various borrower ticket cards (B T Cards) to the students to borrow the books from the library.

1. Two Red B. T. Cards for regular students to issue text books.
2. One Green/Blue Card for regular students to issue reference books or other books for additional reading.
3. One Yellow Card for external members of the library to issue books of various categories such as books on current affairs, general knowledge, books on history, literature, science, and books useful for competitive examination.
4. One extra Red B. T. Card is provided to those students who secure 75 and above percentage of marks in the previous examination.

Students and teachers visit the library to issue books or visit stacking room or reference room to find out the desired book. Approximately 120 users, including students and teachers, use library per day. A well equipped e-library is attached to the reading hall. Students and teachers visit the e-library to search the online study material.

The Library, along with the reading hall and e-library, is open for the students and the staff from 8:00 am to 5:00 pm on all days except Saturday. On Saturday the timing of the library is 8:00 am to 1:00 pm. The college has acquired the membership of INFLIBNET N-List Programme for the benefit of students and staff members. Through the N-list the library provides various e-resources such as - **e-journals, e-ShodhSindhu, e-books, Databases, and Remote access to e-resources**. The library provides books and the journals of various subjects including career guidance and competitive examinations.

This hall is provided with an over head projector, computer with Wi-Fi facility and a wide displayed screen. This hall is quite useful for the organization of seminar, conference, workshop and various cultural activities. A Seminar Room with the seating capacity of 25 persons is provided with over head projector. The institution has an IT Laboratory. This laboratory is provided with good numbers of computers, printers, scanners and internet facilities. The Computer Science laboratory of the institution is fully updated with ICT facilities. It provides the facilities of printer (black and white and colour), scanner, internet and an over head projector. Physics laboratory provides the facility of printer, scanner, internet and an over head projector. Arts Staff Room and Physical Education Departments provide the facilities of printer and internet. Commerce Staff Room provides the facilities of printer, scanner and internet. University Examination Room is provided with the facilities of printer, scanner, internet and a photo copy machine.

The laboratories of Chemistry and Home-Economics, Environmental Science room and NSS departments are provided with the facilities of printer and internet. Mathematics department and IQAC room are provided with the facilities of printer, scanner and internet. The Botany laboratory is provided with the facilities of printer (black and white and colour), scanner, internet and an overhead projector. The Zoology laboratory is provided with the facilities of printer, scanner, internet and an overhead projector. The institutional library is quite updated with ICT facilities. It is provided with the facilities of printer, scanner, photo copy machine and internet. A well equipped e-library is attached to main library. This e-

library is updated with good numbers of computers, an over head projector, internet, etc. The library is updated with the cloud based library software – LIBMAN. The institution provided the BSNL Broadband internet with the bandwidth of 12 MBPS up to 13th March 2023. Recently, from 14th March 2023 the institution has updated the internet speed with the bandwidth of 150 MBPS with the optical network of Airtel. The institution also has a WI-FI instrument. The college office is quite updated with various IT facilities. For its functioning the college uses LMS software. It provides the facilities of printers, scanners, internet, and photo copy machine. The Principal’s office is provided with the facilities of printer, scanner, internet and a printer-cum scanner. The broadband and WI-FI facilities were updated time to time to get increased speed of the internet. Contribution of the Alumni in Teaching-Learning Process:

GOVERNANCE OF INSTITUTION

Bhawabhuti Mahavidyalaya, Amgaon stands as a model of higher education institution in the eastern part of Maharashtra which has been playing the key role in catering higher education in the field of science, arts & commerce to the society and economically backward population of the region. Starting from the founding father of the college Late Shri. Laxmanrao Mankar Guruji to the present management, utmost care has been taken to uphold the great ideas for which the institution is meant for. The Vision and Mission of the college are maintained through democratic governance with the involvement of Management, staff and students.

The governance of the institution to be reflective of and in tune with the vision and mission of the institution, College Development Committee (CDC) is one of the main components of the governing body of the college which is constituted according to the norms prescribed by the Government of Maharashtra in the University Act 2016. The college is run in grant-in-aid basis, recognized under section 2(f) and 12(B) of UGC Act 1956 and permanently affiliated to Rashtrasant Tukadoji Maharaj Nagpur University. The appointments, service rules procedure are complied with the norms laid down by Government of Maharashtra. Moreover, the college is governed by the registered management named Bhawabhuti Shikshan Sanstha. The academic and administrative activities of our college are managed and maintained smoothly sticking to a specific operational structure by adopting the policy of decentralization and democratization. Various statutory and non statutory cells and committee are constituted by ensuring the participation of all the stakeholders. Regular meetings of this committees and cells convened and, in some cases, emergent meetings whenever necessary are held to discuss the issues on hand. Number of proposals at the grass root level is generated and after careful consideration and deliberation they move uprightly. The proposal with all the recommendations are placed before IQAC and subsequently to Principal CDC (College Development Committee) and Governing Body. Besides these statutory bodies, other cells, committees and Council like Admission Committee, Skill Development Cell, Add-on Courses Monitoring Cell, College Website Committee, Time Table Committee, Discipline Committee, Cultural Society, Science Forum, Nature club, Internal Quality Assurance Cell (IQAC), Library Committee, Students' Council, Student Grievance& Anti Raging Committee, Students' Placement and Progression Cell, Academic Plan and Activity Calendar, Environment Education, Women's cell, ICC & Activities, Alumni Association,

NSS, and Committee for Extension Activities work ceaselessly for the accomplishment of administrative activities. The academic activities are coordinated by the Head of the Departments, Faculties, Library Advisory Committee, Research Advisory Committee, Examination Committee etc. Thus, the effective and efficient functioning of the institution is reflected as our institute is abiding by the rules and norms as prescribed in administrative set up. Moreover, the policies, administrative setup, etc. are revealed from the required creations like IQAC, statutory cells, etc. and their working.

After the assessment and accreditation of 2nd cycle, we received a bunch of recommendations from the peer team which propelled us to prepare our perspective plan with a resolution to implement and accomplish them before the 3rd cycle. EFFECTIVE WELFARE MEASURES

The Institution provides several welfare measures for teaching and non-teaching staff. Various monetary, non-monetary measures towards personal and professional growth are being followed to the satisfaction of the employees. Some are briefed as below:

1. The college has a registered co-operative society for the financial well-being of teaching and non-teaching staff bearing registration number ---. Main functions of the society are granting loans, accepting fixed deposits and distributing dividend among the members. Almost all the teaching and non-teaching staff are the members of the society who are eligible to obtain the loan instantaneously at the time of their need. Also, emergency loan is readily available to the regular staff members.
2. Provisions of loans from Provident Fund as per the norms of the government are processed and sanctioned to the staff ensuring the fulfillment of their needfulness.
3. The college provides advance loans without charging any interest to the staff, mainly non-teaching staff, in cases of their necessity.
4. Group Insurance scheme is provided for teaching and non-teaching staff.
5. As per norms due care is taken for availing GPF and DCPS schemes.

Moreover, the physical and mental well-being of the staff has been given Prime importance. Health camps are being organized time to time with the help of specialized doctors and approaching staff. Physical Education Department provides all sports and gymnasium facilities to the staff members for their physical activities. The director of the physical education gives all possible guidance to the staff during their work-out sessions. Yoga camps are also being organized.

Performance Appraisal System

The Faculty members who wish to apply for promotions Under CAS of UGC submit an application to the Head of the Institution that he or she fulfills the qualifications under CAS and they submit the Self Appraisal form in prescribed format. The proposals of eligible teachers are forwarded to the Joint Director Nagpur office verified by IQAC of the college. The faculty maintains record of teaching delivery consisting of records of college work, research Projects and research publications to calculate API Scores. IQAC Coordinator verifies the data and submits the verification report to the Principal. The assessment of performance of faculty members for the CAS promotion is based on indicators such as being regular to class, clarifying doubts of the students within and outside the class, counseling and mentoring of the students, personal development related to teaching and research activities such as attending Orientation/Refresher/Methodology Courses and MOOC's, organizing seminars/conferences/workshops/paper presentation/chairing of session/carrying out research project and publishing books and research papers in National and International Journals. The assessment of Non-Teaching staff is done by observing their promptness, work knowledge, technical skills, and openness to learn new things and behavior with stake holders and students.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

The major source of institutional receipts is the grant in aid received from the state government for salary and non-salary expenditure of Grantable section. The college is also entitled to utilize some part of student fees, as per rules, for meeting routine non-salary expenses. For self-financed courses the major source of receipt is Students' Educational Fees and the deficit is managed by governing body. In the beginning of each academic year the budget is approved and the expenses are done accordingly such as procurement of laboratory equipments, chemicals, books, sport accessories, organization of cultural events, seminars, workshops, renovation of class rooms and laboratories, repairing desk-benches, microscope and other laboratory equipments. Some part of fund is used in procurement of electronic appliances such as Air-conditioner, fans, bulbs, wires etc. All the vouchers, quotations, TDS bills and purchase bills are passed by the Principal and The President/Secretary of the Local Management Body.

The Institution conducts internal and external audits regularly and maintains a record of all financial transactions. The Internal Audit is done by the Chartered Accountant Mr. V. W. AMBEKAR & CO. Nagpur, while the External Audit is done by the Joint Director of Higher Education Nagpur Region, Nagpur, and finally approved by the Auditor General Office, Nagpur. The audit reports are submitted to the Principal. All the Vouchers, TDS, bills, quotations, purchase orders and authorization of payments are examined by both the auditors. Quotations are sought from vendors and the approval is taken from the Principal and the President/Secretary of the Local Management Body. Both the internal and external auditors check the payrolls, form 16, TDS deduction, documentation of tax proofs, etc. The audit of grant and non grant accounts is also done.

PROMOTION OF GENDER EQUITY

The institution promotes gender equity through co-curricular and extracurricular activities. These activities are as follows -

- Almost every year the college conducts the programme like women specific counseling session during New Students Orientation Programme (NSOP) which is organized for the students of Part I of all the three streams (Arts, Commerce and Science).
- The college also organizes a workshop for the students on the awareness of POSCO Act 2012.
- Periodically awareness programs are organized related to the safety and security of women employees and students. Such programmes are very useful for women students.
- Promotion of gender equity in admissions, recruitment, administrative functionality and academic activities
- Celebration of Women Day. On this occasion the success stories of renowned women personalities are narrated to the girl students to inspire them and so as to make them understand their potential.
- Promoting the participation of girls in co-curricular and extra-curricular activities.
- Boys are sensitized to participate in the programmes/competitions such as Rangoli Drawing, Dish Decoration, Musical Chair, etc.
- The college adopted 'Mentor – Mentee' system as the first step towards confidence building among the students. Each faculty is assigned with specific number of students to cater to their psychological and emotional needs.
- Under safety and security initiative CCTV cameras have been installed at prominent places in the college. All types of safety related activities are monitored regularly.

- College has a Tiffin Point inside the premise for the use of students.
- A Girls' common room is available inside the premises for the use of girl students. This girls' common room provides the facility of sanitary napkin to the girl students.
- The college has established the anti-ragging cell and discipline committee in order to provide safety and monitor the proper behavior of the students in the college premise.
- The institute has a policy of appreciating faculty without gender bias. Women faculties have been nominated to various committees based on their abilities as conveners/coordinators/chairpersons and they are discharging their duties efficiently.
- The institution constituted the following committees for the welfare of the students as per norms laid down by Maharashtra Government/University/UGC. These include - Institution Grievance Redressal Committee, Internal Complaints Committee, Students' Council, OBC Welfare Committee, SC /ST Students Welfare Committee. The functions of these committees are displayed on the website of the institution and information is being disseminated to the students through new student orientation program.
- Separate space is provided for girls in the library reading room to avoid inconvenience.

Bhawabhuti Shikshan Sanstha put its tireless efforts to start this organization to provide an inclusive

environment to the people of surrounding region having number of ethnicities along with the objective of catering quality education to the people who are basically poor and underprivileged. As a result, Bhawabhuti Mahavidyalaya has been candid to fundamental values of unity in diversity since its inception. The institution strictly follows the norms of university and governments in conducting admissions to UG and PG programmes. So the specified reservations for SC, ST, NT and other backward classes are confirmed. Meritorious students from all categories are provided with different scholarships by government and university. Hence, compliance of these norms not only curbs socioeconomic diversities but also creates a sense of equality among students. The thing to be marked here is that the students from the other states (outside the Maharashtra) took admission in various Academic Programmes run by the college every year which creates an atmosphere of regional harmony among the students. To create an inclusive environment among the staff and students pertaining to cultural, regional, linguistic and communal diversities, the institution observes various Days reflecting the importance of these diversities. Furthermore, to create a sense of respect among the students towards Marathi, the regional language, the institute observes “Marathi Bhasha Divas”. The college believes in the fundamental values of Indian Constitution like liberty, equality and fraternity. Besides teaching, a number of co-curricular and extracurricular activities are conducted throughout every academic session for which required cells and committees are constituted in the college taking into consideration that all the stakeholders must have equal shares in discharging the responsibilities. Moreover, the elections or unanimous selections of the staff members to many bodies of the college such as CDC (College Development Committee), Staff Council, the Statutory Bodies, Staff Cooperative Society, etc. are held on the democratic principles. Students’ Council is constituted along with confirming the norms affiliating University. Hence, these pro-democratic ways of elections and selections instill a sense of constitutional obligations among the staff and students. The Mentor-Mentee practice assures individual attention of teachers over students’ personal problems and progress. Hence, teachers are always concerned with the primary duties and responsibilities. The ICC (Internal Complaints Committee) of the college is very active to provide safe and secure atmosphere to the female staff and students so as to no incident of sexual harassment can happen in the college. The informative programmes/lectures on legal issues such as ant-ragging, cyber crime, etc. are arranged in the college from the point of view of gender equity.

Most importantly, the institute observes/celebrates various National/International and commemorative Days such as Independence Day, Republic Day, Constitution Day, Teachers’ Day, Gandhi Jayanti, Laxminarayan Day, National Science day etc. which infuse values among the students for being true, trustworthy and responsible citizens of the nation.

The Two Best Practices implemented by the Institution

Note: The data mentioned in these practices below is for the academic year 2021-22 for explaining the implementation process of the practice

First Practice:

1. **Title of the Practice:** - Issuance of the (3rd) Third additional / extra Borrower Ticket Card

(B.T. Card) to all admitted students.

1. Objectives:-

1. To motivate the students for reading additional books other than the text books such as reference books, books on competitive examination, sports, current affairs, etc. for their overall development.
2. To induce habit of book reading among the students while taking the formal education.
3. To build self confidence and self esteem by exhaustive use of library facilities.

1. **The Context:** - The institution is situated in rural area and offers non professional programs. Most of the students seeking admission in the college come from educationally poor and economically deprived background. Just getting a degree is primarily the purpose of taking admission in the college. For career development the admitted students look at the college as a primary source that can open the doors for them in the world full of competition. The institutional library serves this purpose.

2. **The Practice:** - The institutional library has been continuing this practice since last several years. The first two Red color B.T. cards are provided to all the admitted students to borrow the books from the library related to their syllabus for formal study. Apart from these two cards, the 3rd Green /Blue Color B.T. card is provided to each student which can be used to borrow the books such as reference books, biographies, novels, books on sports, current affairs, competitive examinations, etc. The Institutional Library provides one more 4th Red Color B.T. card to the selected meritorious students who secure more than 75 % marks in the Winter University Examination in first attempt.

3. Evidence

of

Success:

Every academic year the number of students taking the advantage of this facility is above 70% of the total admitted students. In the academic year 2021-2022 the total admitted students were 1138. Out of these, 851 students took library membership. That means 05 students availed the facility of extra 3 rd B T card for reading the books other than the text books.

4. Problems Encountered and Resources Required: One of the problems while practicing this practice was that all the admitted students did not approach library to take its membership. The other problem was the lack of interest among the students to borrow the books on the 3rd B T Card. To overcome this problem it is necessary that the the parents should meet the concerned teachers and the librarian and seek the information about the overall performance of their wards on the college campus.

Second practice:

1. Title of the Practices: Felicitation of Meritorious Students.

1. **Objectives:** To motivate the students to set and achieve a particular goal for academic achievement. To build self-confidence, self-esteem and to make optimum use of library/e- library facilities to achieve the goals.
2. **The Context:** The institution is situated in rural area and offers non -professional programs. So to create the interest for study among such students it is necessary to motivate them. Therefore the institution started the practice of felicitating the meritorious students on the occasion of Republic Day on the stage. The institution has been continuing this practice since last several years.
3. **The Practice:** On the occasion of Republic Day the institute felicitates the meritorious students by giving them a certain cash prize at the hands of chief guest. If a student is unable to come to the college to receive the award then his/her parents are allowed to receive the award. The various cash prizes given to the meritorious students during the year 2020-21 are as follows –
 - Cash prize of Rs. 500 /- from the institution to the students who secure 1st position in the Final Year of UG (Arts, Commerce, and Science) and the Final Year of PG (Zoology and Botany)
 - Some cash prizes are given by the Teaching Staff members to the students securing 1st position in the various subjects of First Year and Final Year of UG. Almost all the cash prizes (excluding two prizes) are of Rs. 500/-.
 - Two special cash prizes, (each of Rs 1000/-) one to the best and the other to the needy students are given by the institution under Government of Maharashtra's Mission "Jagar Janivancha"
- A case prize of Rs. 1500/- to good sports person on the occasion of Birth Anniversary of Late Shri Lakshmanrao Mankr Guruji, the founder of Bhawabhuti Shikshan Sanstha.

There are certain other cash prizes for students for their notable performance in examination and sports.

1. **Evidence of Success:** The practice proved fruitful to create a healthy academic competition among students in the college. The students present in the prize distribution function are encouraged to work hard to secure distinguishing marks in the coming examinations. The meritorious students feel greatly privileged when they are honored by the guests in such a grand function on the stage in the presence of large number of students. This practice has established a healthy academic atmosphere among the students.
2. **Problems Encountered and Resources Required:** The main problem that is observed is that most of the students coming from the rural areas fail to secure meritorious marks. The reason for this is the lack of educational background in the families of the rural students. The parents of the rural areas ask their children to do domestic works. As a result these rural students do not get much time to do their studies. To overcome this problem the parents must be invited in the college to ask them to give sufficient time to their wards to do studies

Though the institution is situated in rural area it has its certain distinctiveness to accomplish its vision, mission and priority.

Highlights

- Extra coaching classes for competitive examinations.
- Library facility: Additional extra Borrower Ticket (B.T.) Card provided to every student.

- E-Library: Free internet facility for the use of cyber library.
- Physical Education Department: Indoor Sports Hall, Gymkhana and other services.
- National Service Scheme (NSS)
- Earn While Learn
- Hobby Centre/Workshop
- Research Centre for Higher Education

Keeping in view the vision and the mission of the institution, Competitive Examination Cell, Library Department, Physical Education Department, NSS, Earn While Learn and Hobby Centre organize various activities for the overall development of the students, that is, for intellectual, mental, physical, creative ability and emotional development of the students. Through these various activities students become capable to face the challenges and prepare themselves for the placement or getting the job. Similarly, some of these activities open the door of self-employment for the students.

1. Competitive Examination Cell (Student's Guidance Centre, Career Counseling Cell and Career Katta) provides quite useful information to the students of the college regarding competitive examinations. Similarly, the information in light of availability of various books in different subjects is also provided to the students. MOC test is organized by the Cell for the students of all classes. This test helps the students to prepare themselves before appearing in various competitive examinations such as MPSC, UPSC, IIT, JAM etc.
2. The institution has a well equipped central library with the facility of separate reading hall, stacking room, reference section and e-library. The reading hall in the library provides the sitting capacity of 60 students at a time. In order to develop a good habit of wide reading in college students, the library department provides one extra, that is, 3rd Borrower Ticket card (Green BT card). On this BT card the students get books, other than the text book, from the library for their extra reading. These books help the students to prepare themselves for various competitive examinations.
3. The institution has a E-library library loaded with programmes like consortia, NDL (National Digital Library), etc. It provides opportunity to college students to refer/read books/articles in online mode and thus to update their knowledge. A special facility is provided to the students by e-library. And this facility is the free internet excess available to the students for utilization of e-books, e-journal by employing e-resources like N-list, NDL (National Digital Library), etc. and many more.
4. The institution has a huge ground for the organization and practice of outdoor games and sports. Physical Education Department tries its level best to help the students for their physical development. It provides various equipments required in various games and sports. All necessary facilities are made available to students for indoor as well as outdoor sport activities. Useful coaching is given to students about indoor sports events like table-tennis, chess, badminton, etc. Students are motivated to participate actively in outdoor sports such as cricket, long jump, pole

vault, shot-put, running and many more. Apart from this, college organizes physical training programmes for regular as well as ex-students of the college free of cost. This training prepares the students to qualify the physical test for the entry in police and military services. Apart from college students (including ex students) the college ground is used by the other institutions and the government authorities for the organization of various games/sports. On this college ground Tehsil level (interschool), district level and state level tournaments of various games/sports such as cricket, kho-khko, kabaddi, athletics, etc are organized by various institutions and government authorities.

The institution provides a huge indoor sports hall for the organization and practice of various indoor sports /games such as chess, badminton, table-tennis, taekwondo, etc. Sometimes this hall is used for the organization of some cultural activity or some informative or awareness programme.

The ground and premise of the college is used on every Sunday by a spiritual community (Radhaswami) for the organization of Spiritual Meet (Satsang) for the devotees of this community where a spiritual address is delivered to the devotees.

College has a well equipped 'Gymkhana' with all necessary facilities/equipments for the use of regular and ex-students and the needy local aspirant. It is observed that the sports and gym facilities available in the college are extensively used by several beneficiaries.

5. National Service Scheme (NSS) is one of the prominent units in the institution. The college has Two Units of NSS. Each Unit consists of 125 students. Various social awareness programmes are organized by the NSS Units through regular as well as 7 Days Special Camp activities. Through these activities the students learn the lesson of social responsibilities.

6. College runs "Earn While Learn" activity so as to make the students self- dependent while taking the formal education in the college. The concerned committee provides some work that is to be done inside the college premise to the students of economically deprived category. The work which is given to the students includes electrical repairing, furniture repairing, painting, etc. The type of work which is allotted to the students depends on the liking and capacity of the students. Remuneration against such works is paid to the students by the institution.

7. College has a Hobby Centre/Workshop to take care of different hobbies of the students. Several activities are organized by hobby workshop throughout the academic session. This centre organizes various training programmes for the students. It includes the training of beauty parlor, dish preparation, hair styles, costume wearing styles, mehendi design, rangoli drawing etc. These training pave the way of self-employment for the students, especially the girl students.

8. Though the college is situated in rural area it provides the facility of higher education programmes. The institution has a well equipped research lab with the sophisticated instruments for the research work of the Ph. D. programmes in Botany and Zoology subjects.

5. CONCLUSION

Additional Information :

The institution adheres to its vision, that is, upliftment of educationally and economically deprived people through internal and external evaluation. And for it the institution provides the quality education, programmes and activities to the students. The college is situated in the rural area and 70% of the students come from poor economical and poor educational background. The college was accredited for the first time in the year 2004 by NAAC with 'B' grade. As per the recommendations of the peer team of 1st cycle accreditation the institution provided a well built up infrastructure with upgraded laboratories, a spacious library with separate reading hall and e-library, and so many other facilities to the students. And then in 2nd cycle the institution was awarded with 'A' grade by NAAC in 2016. This is the only institution among the numbers of institutions situated in the rural areas of Gondia district which provides numbers of programmes at UG and PG levels as well as Ph. D. programme in Botany and Zoology. The other thing which is to be highlighted here is that out of total admitted students 70% are girl students. Thus college fulfills the need of rural girl students who cannot go far away from their places for the higher education. Even in COVID-19 Pandemic the institution did not deprive the students from teaching-learning experience. During this period the institution adopted online mode for teaching-learning process. The institution conducts various curricular, co-curricular, and extra-curricular activities to provide ample opportunities to the students to exhibit their hidden talents and thus molding their personality in a right way for their all-round development. Various social outreach programmes have been conducted by NSS Units of the institution. Many NSS students have been awarded for their notable performance in various University Level NSS Camps. The NSS Unit and the NSS programme Officer of the college have been recognized as a best NSS Unit and the best Programme Officer respectively by the affiliating university. The college magazine of the institution 'Yuvaspandan' was awarded with consolation prize for two consecutive years 2018-19 and 2019-20 in intercollegiate competition by affiliating university.

Concluding Remarks :

Though the college is situated in rural area it fulfills the requirement of higher education of educationally and economically poor people of rural area by providing numbers of programmes at UG and PG levels as well as Ph. D. programme in Botany and Zoology. The management is always at the fore-front for the development of the institution. The governance process of the institution is fulfilled through various academic, administrative and statutory bodies such as CDC, IQAC, ICC, etc. The institution believes in decentralization functioning for its easy and noteworthy development. For the all-round development of the students various curricular, co-curricular and extra-curricular committees have been constituted in the institution. For making the teaching-learning process very fruitful, especially in Arts and Commerce streams, the institution provides the education through regional language as well as with the application of ICT tools. The institution provides a well built up infrastructure with upgraded physical and academic facilities including various ICT equipments. To promote the research cultivation in the institution the faculties are continuously involved in research activity. To make aware the students about various social issues the NSS unit of the college is always at the fore-front. Various outreach programmes are organized by the NSS unit of the college. Physical Education department takes utmost effort to provide ample opportunity to the students to exhibit their talents in various games and sports. The huge ground of the college is used by other institutions and NGOs for the organization of various sports/games and tournaments. The institution organizes various programmes/activities to maintain gender equity and cultural and linguistic harmony in the institution. The institution through the organization of various programmes tries to imbibe the morals, values, rights, truths, duties and responsibilities among the students and

the staff. The institutional library plays a major in the academic development of the students by providing numbers of books on various subjects and journals and various e-resources through e-library. The eco-friendly campus, the qualified and experienced teaching staff and the efficient supportive administrative staff provides the positive learning atmosphere to the students.
